



It is hereby notified for information of all concerned that in view of the Judgement and Order dated 11.2.2009 of the Hon'ble Supreme Court of India in the matter of the University of Kerala V/s the Council of Principals of College in Kerala and Others, the following measures shall taken to prevent raggingin the colleges / Institutions:

- 1. In the prospectus of the Higher Educational Institutions, it should be mentioned that if any incident of ragging comes to the notice of the authority concerned, the caused student will be given an opportunity to explain and if his explanation is not satisfactory, the authority would expel him from the institution. The number of cases of ragging and punishment given by the educational institutions in the previous academic year should also be incorporated in the prospectus of Higher Educational Institutions.
- 2. Anti-ragging committees and squads to check ragging should be constituted and the names and telephone numbers of officials to be contacted by the students in case of ragging should also be published.
- 3. Counseling sessions and orientation courses for senior and fresh students be conducted.
- 4. All institutions should do whatever they can ensuring punishment to the students found guilty of ragging, giving wide publicity to such punishments to act as a deterrent, strict enforcement of the various measures for preventing ragging.
- Appropriate messages regarding "Zero Tolerance" towards ragging should be incorporated in admission notices/ advertisements.

- Every year during induction program freshers are made aware of anti ragging laws and working of anti ragging committee.
- To spread awareness anti ragging polices are displayed on college website, prospectus of the college also includes anti ragging policy.
- Anti ragging cell also provide awareness to parents about the rights and safety of their wards during PTA.
- 10.College also upload semester wise anti ragging reports to the Board of Student Development.



The meeting commenced at 11 am with all above mentioned members joining in an online meet. As the committee was newly formulated effective from the A.Y. 21-22, all the members introduced themselves.

Points on the Agenda and resolutions taken.

Point 1. Review of MoM of meeting conducted on 15.02.21 & Action taken report

The Chairperson read out the salient points in the MoM of the meeting conducted on 15.02.21 and gave the action taken report.

All members took note of the same.





Point 2. Activities to be conducted for creating awareness of ICC and harassment of women.

Dr. Arun Patil commented on increasing the awareness of ICC amongst students through the Batch Guardians. Mrs. Vaishali Barse also commented on the same and mentioned that it was her observation that few girl students who had faced some difficulties would resolve the issues amongst themselves and were to a large extent unaware of ICC and the procedure for lodging complaints. Mrs. Anjum Patel was of the opinion that awareness sessions be held not only for students but also for employees of both genders, at least once a year, Dr. Shital Mantri stated that display boards be put up at prominent spots in the institute and at the entrance of every department; that the also mention that 'confidentiality is assured' to the complainant. She also suggested that a poster competition be held amongst students on the theme 'Safe Spaces' creating an awareness of the requirement and sensitizing the students towards the issue in the campus. She also suggested that a separate official mailid be created for ICC to receive and address official communication and also shared information about self defense workshop that Women Empowerment Cell had planned for girl students.

It was resolved that an offline awareness program be conducted especially for First Year Students of both genders. That Class and Batch Representatives also attend the same and carry the message to the rest of the students helping spread awareness of ICC.

It is also resolved that a separate awareness session be held for staff of both genders.

A poster competition will also be held on 'Safe Spaces' this semester.

All members seconded the above resolution.

Point 3. Precautions to be taken while using digital platforms.

Though this point was more relevant when classes were conducted in online mode, it still needs attention due to the hybrid mode of interaction with students and staff alike. It was thought that there is a necessity to create awareness as to what precautions needed to be taken by students when in online mode. Mrs. Vaishali Barse suggested that "Digital Harassment" be included in the awareness creating activity that was planned for the students.

It is, therefore, resolved that 'Digital Harassment and Precautions to be taken be included in the activity being planned for the students.

Point 4. Follow up on updating of information regarding ICC on the institute website.





Mrs. Vaishali Barse suggested that a document on ICC be prepared and approved by the members before displaying the information on the institute website. The information should include (i) UGC Guidelines on Sexual Harassment (ii) Posch Act and Law (ili) Procedure for submitting a sexual harassment complaint with guidelines on who can submit it including format for submission of complaint/s.

It is resolved that a document be prepared by all and shared for approval before displaying on the institute website. That Prof. Vaishali Barse drafts the process and the complaints format to add to the document.

Point 5. Any other points with the permission of the chair

1. Prof. Vaishali Barse commented on the amendment of Internal Complaints Committee to Internal Committee (Ref: The Sexual Harassment of Women at Work Place (Prevention, Prohibition and Redressal) Act, 2013; Amendments as notified in the Gazette). It is therefore resolved that, in line with the amendment, the committee will, henceforth, be formally addressed, as the Internal Committee. She also added that this is a statutory body addressing complaints/sexual harassment faced by women only as stated in the UGC guidelines.

It is resolved that the internal Complaints Committee be officially addressed as the Internal Committee.

1. Mrs. Anjum Patel reminded the committee that an Annual Report for the Calendar Year be submitted in the 1st week of January of the subsequent year to the following: (i) District Officer -

[Sexual Harassment of Women (PPR) Act, 2013]

District Women and Child development Office, Pune District.

(ii) Deputy Collector

(District Officer for Pune district under the POSH act)



 Vaishali Barse has agreed to shoulder the responsibility to form these policies.













